What does the fund invest in?

The fund invests in Franklin Global Growth Fund, which invests primarily in equity securities of growth companies with any size market capitalization that are located throughout the world.

How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Franklin Templeton has rated the volatility of this fund as **medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

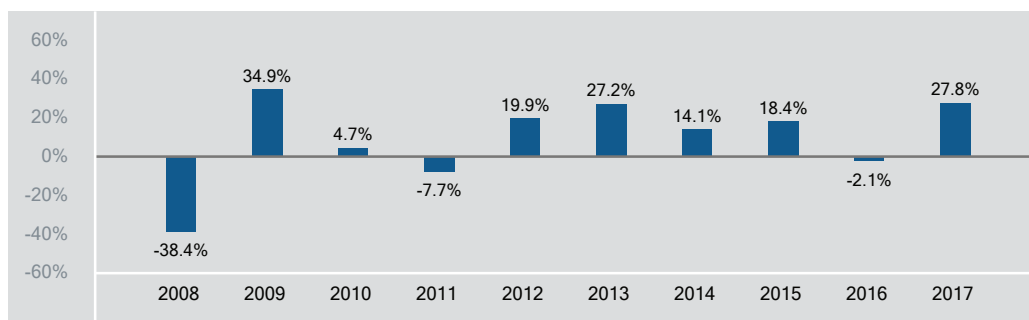
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how Series 0 securities of the fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

YEAR-BY-YEAR RETURNS

This chart shows how Series 0 securities of the fund have performed in each of the past 10 years. The series dropped in value in 3 of the 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Effective June 13, 2008, Franklin Global Growth Corporate Class began investing primarily in securities of a newly launched Franklin Global Growth Fund.

AVERAGE RETURN

The annual compounded return of Series 0 securities of the fund was 8.94% over the past 10 years. If you had invested \$1,000 in the fund 10 years ago, your investment would be now worth \$2,354.

Who is this fund for?

Investors who:

- want to invest in high-growth potential companies around the world to be held outside a registered plan
- invest for a medium to long term
- can handle the ups and downs of the stock market

This fund is focused on capital appreciation. It is not intended for investors who need a steady source of income from their investment.

This series is also available in U.S. dollars.

A word about tax

In general, you pay income tax on your share of the fund's earnings and on any gains you realize from redeeming your investment. The amount of tax depends on the tax rules and rates that apply to you, and whether you hold the fund in a registered plan, such as an RRSP or TFSA.

If you hold the fund in a non-registered account, we send a tax slip that shows your share of the fund's earnings. You must calculate your gains on redemption.

Investors switching between Corporate Class Funds will trigger a capital gain or loss at the time of the switch.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series O securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. SALES CHARGES

There are no sales charges for Series O securities of the fund.

2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the fund's returns. As of December 31, 2017, the expenses of Series O were 0.09% of the value of this series. This equals \$0.90 for every \$1,000 invested.

3. OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Management and administration fee	<p>The fund does not pay a management or administration fee to Franklin Templeton for this series. Instead, a management and administration fee is paid directly by you to Franklin Templeton as follows:</p> <ul style="list-style-type: none"> • First C\$200,000 to under \$2.5M – 0.95% • Next C\$2.5M to under \$5M – 0.80% • C\$5M and over – 0.75% <p>Certain institutional investors may negotiate the management and administration fee by written agreement with Franklin Templeton.</p>
Investment advisory services fee	<p>You pay your representative's firm an investment advisory services fee, which you negotiate directly with your representative. This fee is paid for as long as you own this series of the fund. Franklin Templeton will collect the investment advisory services fee (plus any applicable taxes) from you on behalf of your representative's firm by redeeming securities of this series of the fund in your account and remitting the amount to your representative's firm. The maximum annual investment advisory services fee that we collect on behalf of your representative's firm is 1.50%.</p>

What if I change my mind?

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
