What does the fund invest in?

The fund invests primarily in a diversified portfolio of debt and equity securities issued in the U.S.

How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Franklin Templeton has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

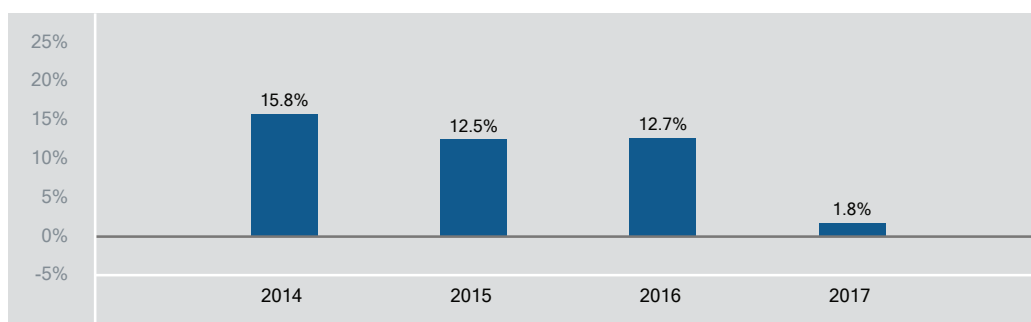
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how Series FT securities of the fund have performed over the past 4 years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

YEAR-BY-YEAR RETURNS

This chart shows how Series FT securities of the fund have performed in each of the past 4 years. The series did not drop in value in any of those years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

AVERAGE RETURN

The annual compounded return of Series FT securities of the fund was 10.44% since inception. If you had invested \$1,000 in the fund since inception, your investment would be now worth \$1,604.

Who is this fund for?

Investors who:

- seek a high level of current income primarily from U.S. issuers while maintaining prospects for capital appreciation
- seek access to a portfolio of both equity and fixed-income securities via a single fund
- invest for a medium to long term
- want regular monthly cash flows (if any)

Since this fund invests in high yield fixed income instruments, it may be subject to additional risks that may not be suitable for more conservative investors.

This series is also available in U.S. dollars.

This series is not intended for investment in your registered plan.

Series FT securities are only available to investors approved by Franklin Templeton for whom Franklin Templeton does not incur distribution costs.

A word about tax

In general, you pay income tax on your share of the fund's earnings and on any gains you realize from redeeming your investment. The amount of tax depends on the tax rules and rates that apply to you, and whether you hold the fund in a registered plan, such as an RRSP or TFSA.

If you hold the fund in a non-registered account, we send a tax slip that shows your share of the fund's earnings. You must calculate your gains on redemption.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series FT securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. SALES CHARGES

There are no sales charges for Series FT securities of the fund.

2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the series' returns. As of December 31, 2017, the expenses of Series FT were 1.13% of the value of this series. This equals \$11.30 for every \$1,000 invested.

We will switch your Series FT securities into Series PFT securities of the fund (bearing lower combined management and administration fees) upon your investment in related Franklin Templeton accounts meeting the Series PFT eligibility requirements of \$100,000. The combined management and administration fee decrease (from Series FT to Series PFT) is 0.19%. If you no longer meet the eligibility requirements for Series PFT, we will switch your securities back to Series FT securities, which have a higher combined management and administration fee. See "Fees and Expenses" in the fund's simplified prospectus and speak to your representative for additional details.

More about the trailing commission

No trailing commission is paid by Franklin Templeton to your representative's firm in respect of Series FT securities. Please see "Representative's Firm Fees" below.

3. OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
Representative's Firm Fees	No trailing commission is paid by Franklin Templeton to your representative's firm in respect of this series. Instead, you may buy and hold this series of securities in a fee-based account at your representative's firm. If you hold your securities in a fee-based account, you negotiate the fee and pay it directly to your representative's firm.
Investment advisory services fee*	If you do not hold this series of securities in a fee-based account at your representative's firm, you may buy this series by opting into our investment advisory services fee option. If this option is chosen by you, Franklin Templeton will collect the fee (plus any applicable taxes) from you on behalf of your representative's firm by redeeming securities of this series of the fund in your account and remitting the amount to your representative's firm. With this fee option, the maximum annual investment advisory services fee that we collect on behalf of your representative's firm is 1.50%.
Switch fee	Up to 2% of the value of the switched securities. You negotiate this amount with, and pay it to, your representative's firm. A switch from Series FT securities of the fund to Series FT securities of another fund will not be subject to switch fees. Your representative's firm may charge you a switch fee for switches from Series FT to any other series.

* The effective date of availability of this purchase fee option is August 7, 2018.

What if I change my mind?

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
