## What does the fund invest in?

The fund invests in Templeton Asian Growth Fund, which invests primarily in equity securities of companies located in the Asia region including, but not limited to Hong Kong, India, Indonesia, Korea, Malaysia, People's Republic of China, Pakistan, Philippines, Singapore, Sri Lanka, Taiwan, Thailand and Vietnam and in companies expected to benefit from developments in the economies of the Asia region using Templeton's value investing style.

# How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## **Risk rating**

Franklin Templeton has rated the volatility of this fund as medium to high

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.


# How has the fund performed?

This section tells you how Series I securities of the fund have performed over the past 7 years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

#### YEAR-BY-YEAR RETURNS

This chart shows how Series I securities of the fund have performed in each of the past 7 years. The series dropped in value in 2 of the 7 years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

#### **AVERAGE RETURN**

The annual compounded return of Series I securities of the fund was 2.13% since inception. If you had invested \$1,000 in the fund since inception, your investment would be now worth \$1,165.

# Who is this fund for?

Investors who:

- want to access the above average capital gain potential of a fund concentrated on the Asian region, on its own or as a small part of a well-diversified portfolio
- invest for the long term
- are very comfortable with the ups and downs of the stock market

This fund is focused on capital appreciation. It is not intended for investors who need a steady source of income from their investment.

This series is also available in U.S. dollars.

# A word about tax

In general, you pay income tax on your share of the fund's earnings and on any gains you realize from redeeming your investment. The amount of tax depends on the tax rules and rates that apply to you, and whether you hold the fund in a registered plan, such as an RRSP or TFSA.

If you hold the fund in a non-registered account, we send a tax slip that shows your share of the fund's earnings. You must calculate your gains on redemption.

Investors switching between Corporate Class Funds will trigger a capital gain or loss at the time of the switch.

#### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series I securities of the fund. The fees and expenses — including any commissions — can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

#### 1. SALES CHARGES

Series I securities are only available under the initial sales charge option.

#### 2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the series' returns. As of December 31, 2017, the expenses of Series I were 2.65% of the value of this series. This equals \$26.50 for every \$1,000 invested.

## More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and/or advice that your representative and/or their firm provide to you.

Franklin Templeton pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate is 0.750% of the value of your investment each year. This equals \$7.50 each year for every \$1,000 invested.

## 3. OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
Switch fee	Up to 2% of the value of the switched securities. You negotiate this amount with, and pay it to, your representative's firm. Your representative's firm may charge you a switch fee for the following: switches from securities bought under the initial sales charge option to securities without a sales charge or securities bought under the initial sales charge option.

# What if I change my mind?

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
