### What does the fund invest in?

The fund invests in Franklin Mutual Global Discovery Fund, which invests primarily in equity and debt securities of issuers around the world using Mutual Series' deep value investing style.

### How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

Franklin Templeton has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

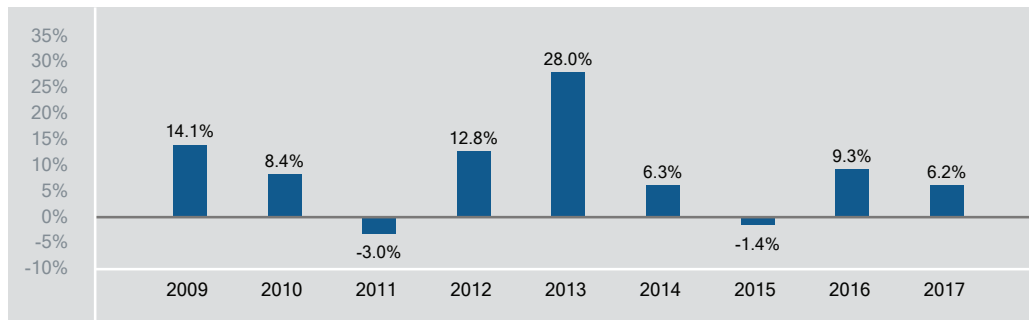
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

## How has the fund performed?

This section tells you how Series T—USD securities of the fund have performed over the past 9 years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

### YEAR-BY-YEAR RETURNS

This chart shows how Series T—USD securities of the fund have performed in each of the past 9 years. The series dropped in value in 2 of the 9 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

### AVERAGE RETURN

The annual compounded return of Series T—USD securities of the fund was 6.48% over the past 10 years. If you had invested \$1,000 in the fund 10 years ago, your investment would be now worth \$1,874.

## Who is this fund for?

Investors who:

- want to invest in undervalued securities from around the world
- invest for a medium to long term
- want regular monthly cash flows in U.S. dollars
- want cash flow consisting of non-taxable return of capital
- can handle the ups and downs of the stock market

Monthly distributions are in an amount fixed in U.S. dollars and will not change based on the exchange rate of the Canadian dollar.

This series is not intended for investment in your registered plan.

## A word about tax

In general, you pay income tax on your share of the fund's earnings and on any gains you realize from redeeming your investment. The amount of tax depends on the tax rules and rates that apply to you, and whether you hold the fund in a registered plan, such as an RRSP or TFSA. If you hold the fund in a non-registered account, we send a tax slip that shows your share of the fund's earnings. You must calculate your gains on redemption.

Investors switching between Corporate Class Funds will trigger a capital gain or loss at the time of the switch.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series T–USD securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

Effective January 25, 2019, we will switch your Series T–USD securities into Series PT–USD securities of the fund (bearing lower combined management and administration fees) upon your account(s) meeting the minimum investment threshold of \$200,000 in qualifying Franklin Templeton funds. If you no longer meet the eligibility requirements for Series PT–USD, we will switch your securities back to Series T–USD securities which have a higher combined management and administration fee. For more information on the fees for the applicable series, see the “Fund Expenses” section below and the “Fees and Expenses” section in the fund’s simplified prospectus and speak to your representative for additional details.

### 1. SALES CHARGES

You have to choose a sales charge option when you buy this series of the fund. Ask about the pros and cons of each option.

### 2. FUND EXPENSES

You don’t pay these expenses directly. They affect you because they reduce the series’ returns. As of June 30, 2018, the expenses of Series T–USD were 2.41% of the value of this series. This equals \$24.10 for every \$1,000 invested.

Effective January 25, 2019, the combined management and administration fee decrease from Series T–USD to Series PT–USD is 0.38%.

**More about the trailing commission**

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and/or advice that your representative and/or their firm provide to you.

Franklin Templeton pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose:

- **Initial sales charge** – 1.000% of the value of your investment each year. This equals \$10.00 each year for every \$1,000 invested.
- **Low-load sales charge** – 0.500% of the value of your investment each year for securities outstanding for less than three years. 1.000% of the value of your investment each year for securities outstanding for more than three years. This equals \$5.00 and \$10.00, respectively, each year for every \$1,000 invested.
- **Deferred sales charge** – 0.500% of the value of your investment each year for securities outstanding for less than six years. 1.000% of the value of your investment each year for securities outstanding for more than six years. This equals \$5.00 and \$10.00, respectively, each year for every \$1,000 invested.

**3. OTHER FEES**

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
<b>Switch fee</b>	Up to 2% of the value of the switched securities. You negotiate this amount with, and pay it to, your representative's firm. Your representative's firm may charge you a switch fee for the following: <ul style="list-style-type: none"> <li>• switches from securities bought under the initial sales charge option to securities without a sales charge option or under the initial sales charge option</li> <li>• switches from securities bought under the low-load sales charge option to securities under the low-load sales charge option</li> <li>• switches from securities bought under the deferred sales charge option to securities under the deferred sales charge option.</li> </ul>

**What if I change my mind?**

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
